Power (social and political)

In political science, power is the ability to influence or direct the actions, beliefs, or conduct of actors. Power does not exclusively refer to the threat

In political science, power is the ability to influence or direct the actions, beliefs, or conduct of actors. Power does not exclusively refer to the threat or use of force (coercion) by one actor against another, but may also be exerted through diffuse means (such as institutions).

Power may also take structural forms, as it orders actors in relation to one another (such as distinguishing between a master and an enslaved person, a householder and their relatives, an employer and their employees, a parent and a child, a political representative and their voters, etc.), and discursive forms, as categories and language may lend legitimacy to some behaviors and groups over others.

The term authority is often used for power that is perceived as legitimate or socially approved by the social structure.

Scholars have distinguished between soft power and hard power.

Theory of International Politics is a 1979 book on international relations theory by Kenneth Waltz that creates a structural realist theory, neorealism, to explain international relations. Taking into account the influence of neoclassical economic theory, Waltz argued that the fundamental "ordering principle" (p. 88) of the international political system is anarchy, which is defined by the presence of "functionally undifferentiated" (p. 97) individual state actors lacking "relations of super- and subordination" (p. 88) that are distinguished only by their varying capabilities.

Waltz challenges reductionist approaches to international politics, arguing that they fail to account for similar behaviors across states (Ch. 4). According to Waltz, system-level processes of socialization and competition lead states to behave in similar ways (p. 76).

Waltz argues that broad patterns of state behavior can be understood as a consequence of states pursuing incentives provided by the anarchic structure of the international system. He argues that states pursue their security above other goals, which limits the potential for cooperation and creates security competition. One of the major findings of the book is that states tend to balance against power, which leads to the persistent formation of balances of power. Waltz also argues that bipolarity (the presence of two great powers) is more stable than multipolarity (the presence of three or more great powers).

It is arguably the most influential book in international relations, causing a fundamental discursive transformation and bringing the concept of anarchy to the forefront. It is the most assigned book in International Relations graduate training at U.S. universities. John Mearsheimer describes it as among the three most influential realist works of international relations of the 20th century, Charles Glaser characterized it as the "defining work" in the neorealist international relations literature, and Robert Jervis wrote in 1998 that the book was "the most important book in the field in the past decade." The book caused a resurgence of realism in the field of international relations.

Soft power

In politics (and particularly in international politics), soft power is the ability to co-opt rather than coerce (in contrast with hard power). It involves

In politics (and particularly in international politics), soft power is the ability to co-opt rather than coerce (in contrast with hard power). It involves shaping the preferences of others through appeal and attraction. Soft power is non-coercive, using culture, political values, and foreign policies to enact change. In 2012, Joseph Nye of Harvard University explained that with soft power, "the best propaganda is not propaganda", further explaining that during the Information Age, "credibility is the scarcest resource".

Nye popularised the term in his 1990 book, *Bound to Lead: The Changing Nature of American Power*.

In this book he wrote: "when one country gets other countries to want what it wants might be called co-optive or soft power in contrast with the hard or command power of ordering others to do what it wants". He further developed the concept in his 2004 book, *Soft Power: The Means to Success in World Politics*.

The Tragedy of Great Power Politics

The Tragedy of Great Power Politics is a book by the American scholar John Mearsheimer on the subject of international relations theory published by W. W. Norton & Company in 2001. Mearsheimer explains and argues for his theory of "offensive realism" by stating its key assumptions, evolution from early realist theory, and its predictive capability. An article adapted from the book had previously been published by Foreign Affairs.

The five bed-rock assumptions of Mearsheimer's theory of offensive realism are:

Anarchy: the international system is anarchic;

Offensive military capabilities: all great powers possess offensive military capabilities which they can use against each other;

Uncertainty: states cannot be sure that other states will not use military capabilities against them;

Survival: the primary goal of states is survival;

Rationality: states are rational unitary actors who think strategically about how to pursue their primary goal (survival).

From these assumptions, Mearsheimer argues that states will constantly seek to accumulate power, and that cooperation between states is hard. The "tragedy" of great power politics is that even security-seeking great powers will nonetheless be forced to engage in competition and conflict with one another.

The Book of Enoch (also 1 Enoch;

Hebrew: סֵפֶר עֲנוֹךְ, Səfer ʿEnōḵ; Ge'ez: መዝሐር ክብሩ, Maḥṣar Kibru) is an ancient Jewish apocalyptic religious text, ascribed by tradition to the patriarch Enoch who was the father of Methuselah and the great-grandfather of Noah. The Book of Enoch contains unique material on the origins of demons and Nephilim, why some angels fell from heaven, an explanation of why the Genesis flood was morally necessary, and a prophetic exposition of the thousand-year reign of the Messiah. Three books are traditionally attributed to Enoch, including the distinct works 2 Enoch and 3 Enoch.

1 Enoch is not considered to be canonical scripture by most Jewish or Christian church bodies, although it is part of the biblical canon used by the Ethiopian Jewish community Beta Israel, as well as the Ethiopian Orthodox Tewahedo Church and Eritrean Orthodox Tewahedo Church.

The older sections of 1 Enoch are estimated to date from about 300–200 BCE, and the latest part (Book of Parables) is probably from around 100 BCE. Scholars believe Enoch was originally written in either Aramaic or Hebrew, the languages first used for Jewish texts. Ephraim Isaac suggests that the Book of Enoch, like the Book of Daniel, was composed partially in Aramaic and partially in Hebrew. No Hebrew version is known to have survived. Copies of the earlier sections of 1 Enoch were preserved in Aramaic among the Dead Sea Scrolls in the Qumran Caves.

Authors of the New Testament were also familiar with some content of the book. A short section of 1 Enoch is cited in the Epistle of Jude, Jude 1:14–15, and attributed there to "Enoch the Seventh from Adam" (1 Enoch 60:8), although this section of 1 Enoch is a midrash on Deuteronomy 33:2, which was written long after the supposed time of Enoch. The full Book of Enoch only survives in its entirety in the Ge'ez translation.

The book applies insights from institutional economics, development economics, and economic history to understand why nations develop differently, with some succeeding in the accumulation of power and prosperity and others failing, according to a wide range of historical case studies.

The authors also maintain a website (with a blog inactive since 2014) about the ongoing discussion of the book.

In international relations, power is defined in several different ways. Material definitions of state power emphasize economic and military power. Other definitions of power emphasize the ability to structure and constitute the nature of social relations between actors. Power is an attribute of particular actors in their interactions, as well as a social process that constitutes the social identities and capacities of actors.

International relations scholars use the term polarity to describe the distribution of power in the international system. Unipolarity refers to an international system characterized by one hegemon (e.g. the United States in the post–Cold War era), bipolarity to an order with two great powers or blocs of states (e.g. the Cold War), and multipolarity refers to the presence of three or more great powers. Those states that have significant amounts of power within the international system are referred to as small powers, middle powers, regional powers, great powers, superpowers, or hegemons, although there is no commonly accepted standard for what defines a powerful state.

Entities other than states can have power in international relations. Such entities can include multilateral international organizations, military alliance organizations like NATO, multinational corporations like Walmart, non-governmental organizations such as the Roman Catholic Church, or other institutions such as the Hanseatic League and technology companies like Facebook and Google.

Right-wing politics

Right-wing politics is the range of political ideologies that view certain social orders and hierarchies as inevitable, natural, normal, or desirable

Right-wing politics is the range of political ideologies that view certain social orders and hierarchies as inevitable, natural, normal, or desirable, typically supporting this position based on natural law, economics, authority, property, religion, or tradition. Hierarchy and inequality may be seen as natural results of traditional social differences or competition in market economies.

Right-wing politics are considered the counterpart to left-wing politics, and the left–right political spectrum is the most common political spectrum. The right includes social conservatives and fiscal conservatives, as well as right-libertarians. "Right" and "right-wing" have been variously used as compliments and pejoratives describing neoliberal, conservative, and fascist economic and social ideas.
