## Political corruption

*state phenomenon is an example of institutional corruption. An illegal act by an officeholder constitutes political corruption only if the act is directly*

Political corruption is the use of powers by government officials or their network contacts for illegitimate private gain. Forms of corruption vary but can include bribery, lobbying, extortion, cronyism, nepotism, parochialism, patronage, influence peddling, graft, and embezzlement. Corruption may facilitate criminal enterprise, such as drug trafficking, money laundering, and human trafficking, although it is not restricted to these activities.

Over time, corruption has been defined differently. For example, while performing work for a government or as a representative, it is unethical to accept a gift. Any free gift could be construed as a scheme to lure the recipient towards some biases. In most cases, the gift is seen as an intention to seek certain favors, such as work promotion, tipping in order to win a contract, job, or exemption from certain tasks in the case of junior worker handing in the gift to a senior employee who can be key in winning the favor.

Some forms of corruption, now called "institutional corruption", are distinguished from bribery and other kinds of obvious personal gain. For example, certain state institutions may consistently act against the interests of the public, such as by misusing public funds for their own interest, or by engaging in illegal or immoral behavior with impunity. Bribery and overt criminal acts by individuals may not necessarily be evident but the institution nonetheless acts immorally as a whole. The mafia state phenomenon is an example of institutional corruption.

An illegal act by an officeholder constitutes political corruption only if the act is directly related to their official duties, is done under color of law or involves trading in influence. The activities that constitute illegal corruption differ depending on the country or jurisdiction. For instance, some political funding practices that are legal in one place may be illegal in another. In some cases, government officials have broad or ill-defined powers, which make it difficult to distinguish between legal and illegal actions. Worldwide, bribery alone is estimated to involve over 1 trillion US dollars annually. A state of unrestrained political corruption is known as a kleptocracy, literally meaning "rule by thieves".

## Central bank

A central bank, reserve bank, national bank, or monetary authority is an institution that manages the monetary policy of a country or monetary union. In contrast to a commercial bank, a central bank possesses a monopoly on increasing the monetary base. Many central banks also have supervisory or regulatory powers to ensure the stability of commercial banks in their jurisdiction, to prevent bank runs, and, in some cases, to enforce policies on financial consumer protection, and against bank fraud, money laundering, or terrorism financing. Central banks play a crucial role in macroeconomic forecasting, which is essential for guiding monetary policy decisions, especially during times of economic turbulence.

Central banks in most developed nations are usually set up to be institutionally independent from political interference, even though governments typically have governance rights over them, legislative bodies exercise scrutiny, and central banks frequently do show responsiveness to politics.

Issues like central bank independence, central bank policies, and rhetoric in central bank governors' discourse or the premises of macroeconomic policies (monetary and fiscal policy) of the state, are a focus of contention and criticism by some policymakers, researchers, and specialized business, economics, and finance media.

## Social cognitive theory

Social cognitive theory (SCT), used in psychology, education, and communication, holds that portions of an individual's knowledge acquisition can be directly related to observing others within the context of social interactions, experiences, and outside media influences. This theory was advanced by Albert Bandura as an extension of his social learning theory. The theory states that when people observe a model performing a behavior and the consequences of that behavior, they remember the sequence of events and use this information to guide subsequent behaviors. Observing a model can also prompt the viewer to engage in behavior they already learned. Depending on whether people are rewarded or punished for their behavior and the outcome of the behavior, the observer may choose to replicate behavior modeled. Media provides models for a vast array of people in many different environmental settings.

## Distribution of wealth

The distribution of wealth is a comparison of the wealth of various members or groups in a society. It shows one aspect of economic inequality or economic heterogeneity.

The distribution of wealth differs from the income distribution in that it looks at the economic distribution of ownership of the assets in a society, rather than the current income of members of that society. According to the International Association for Research in Income and Wealth, "the world distribution of wealth is much more unequal than that of income."

## Surfing

Surfing is a surface water sport in which an individual, a surfer (or two in tandem surfing), uses a board to ride on the forward section, or face, of a moving wave of water, which usually carries the surfer towards the shore. Waves suitable for surfing are primarily found on ocean shores, but can also be found as standing waves in the open ocean, in lakes, in rivers in the form of a tidal bore, or wave pools.

Surfing includes all forms of wave-riding using a board, regardless of the stance. There are several types of boards. The Moche of Peru would often surf on reed craft, while the native peoples of the Pacific surfed waves on alaia, paipo, and other such watercraft. Ancient cultures often surfed on their belly and knees, while modern-day surfing is most often stand-up surfing, in which a surfer rides a wave while standing on a surfboard.

Another prominent form of surfing is body boarding, where a surfer rides the wave on a bodyboard, either lying on their belly, drop knee (one foot and one knee on the board), or sometimes even standing up on a body board. Other types of surfing include knee boarding, surf matting (riding inflatable mats) and using foils. Body surfing, in which the wave is caught and ridden using the surfer's own body rather than a board, is

very common and is considered by some surfers to be the purest form of surfing. The closest form of body surfing using a board is a handboard which normally has one strap over it to fit on one hand. Surfers who body board, body surf, or handboard feel more drag as they move through the water than stand up surfers do. This holds body surfers into a more turbulent part of the wave (often completely submerged by whitewater). In contrast, surfers who instead ride a hydrofoil feel substantially less drag and may ride unbroken waves in the open ocean.

Three major subdivisions within stand-up surfing are stand-up paddling, long boarding and short boarding with several major differences including the board design and length, the riding style and the kind of wave that is ridden.

In tow-in surfing (most often, but not exclusively, associated with big wave surfing), a motorized water vehicle such as a personal watercraft, tows the surfer into the wave front, helping the surfer match a large wave's speed, which is generally a higher speed than a self-propelled surfer can produce. Surfing-related sports such as paddle boarding and sea kayaking that are self-propelled by hand paddles do not require waves, and other derivative sports such as kite surfing and windsurfing rely primarily on wind for power, yet all of these platforms may also be used to ride waves. Recently with the use of V-drive boats, wakesurfing, in which one surfs on the wake of a boat, has emerged. As of 2023, the Guinness Book of World Records recognized a 26.2 m (86 ft) wave ride by Sebastian Steudtner in Nazaré, Portugal, as the largest wave ever surfed.

During the winter season in the northern hemisphere, the North Shore of Oahu, the third-largest island of Hawaii, is known for having some of the best waves in the world. Surfers from around the world flock to breaks like Backdoor, Waimea Bay, and Pipeline. However, there are still many popular surf spots around the world: Teahupo'o, located off the coast of Tahiti; Mavericks, California, United States; Cloudbreak, Tavarua Island, Fiji; Superbank, Gold Coast, Australia.

In 2016, surfing was added by the International Olympic Committee (IOC) as an Olympic sport to begin at the 2020 Summer Olympics in Japan.

The first gold medalists of the Tokyo 2020 surfing men and women's competitions were, respectively, the Brazilian Ítalo Ferreira and the American from Hawaii, Carissa Moore.

Beta Israel

The Beta Israel, or Ethiopian Jews, are a Jewish group originating in the Amhara and Tigray regions of northern Ethiopia, where they were historically spread out across more than 500 small villages. The majority were concentrated in what is today North Gondar Zone, Shire Inda Selassie, Wolqayit, Tselemti, Dembia, Segelt, Quara, and Belesa. Since their official recognition as Jewish under Israel's Law of Return, most of the Beta Israel immigrated to Israel, through several Israeli government initiatives starting in 1979.

The ethnogenesis of the Beta Israel is disputed, with genetic studies showing them to cluster closely with non-Jewish Amharas and Tigrayans, with no indications of gene flow with Yemenite Jews in spite of their geographic proximity.

The Beta Israel appear to have been lastingly isolated from broader Jewish communities, having historically practiced a divergent non-Talmudic form of Judaism that is similar in some respects to Karaite Judaism. The religious practices of Israeli Beta Israel are referred to as Haymanot.

Due to Christian missionary activity, and persecution by the authorities, a significant portion of the Beta Israel community converted to Christianity during the 19th and 20th centuries. Those who converted to

Christianity later became known as the Falash Mura. The larger Christian Beta Abraham community is considered to be a crypto-Jewish offshoot of the Beta Israel community.

The Beta Israel first made extensive contact with other Jewish communities in the early 20th century, after which a comprehensive rabbinic debate ensued over their Jewishness. Following halakhic and constitutional discussions, Israeli authorities decided in 1977 that the Beta Israel qualified on all fronts for the Israeli Law of Return. Thus, the Israeli government, with support from the United States, began a large-scale effort to conduct transport operations and bring the Beta Israel to Israel in multiple waves. These activities included Operation Banyarwanda, Operation Brothers, which evacuated the Beta Israel community in Sudan between 1979 and 1990 (including Operation Moses in 1984 and Operation Joshua in 1985), and Operation Solomon in 1991.

By the end of 2008, 119,300 Ethiopian Jews were living in Israel, including nearly 81,000 born in Ethiopia and about 38,500 (about 32% of the Ethiopian Jewish community in Israel) born in Israel with at least one parent born in Ethiopia or Eritrea (formerly a part of Ethiopia). At the end of 2019, there were 155,300 Jews of Ethiopian descent in Israel. Approximately 87,500 were born in Ethiopia, and 67,800 were born in Israel with parents born in Ethiopia. The Ethiopian Jewish community in Israel is mostly composed of Beta Israel (practicing both Haymanot and Rabbinic Judaism), but includes smaller numbers of Falash Mura who left Christianity and began practicing Rabbinic Judaism upon their arrival in Israel.

## Sea

A sea is a large body of salt water. There are particular seas and the sea. The sea commonly refers to the ocean, the interconnected body of seawaters that spans most of Earth. Particular seas are either marginal seas, second-order sections of the oceanic sea (e.g. the Mediterranean Sea), or certain large, nearly landlocked bodies of water.

The salinity of water bodies varies widely, being lower near the surface and the mouths of large rivers and higher in the depths of the ocean; however, the relative proportions of dissolved salts vary little across the oceans. The most abundant solid dissolved in seawater is sodium chloride. The water also contains salts of magnesium, calcium, potassium, and mercury, among other elements, some in minute concentrations. A wide variety of organisms, including bacteria, protists, algae, plants, fungi, and animals live in various marine habitats and ecosystems throughout the seas. These range vertically from the sunlit surface and shoreline to the great depths and pressures of the cold, dark abyssal zone, and in latitude from the cold waters under polar ice caps to the warm waters of coral reefs in tropical regions. Many of the major groups of organisms evolved in the sea and life may have started there.

The ocean moderates Earth's climate and has important roles in the water, carbon, and nitrogen cycles. The surface of water interacts with the atmosphere, exchanging properties such as particles and temperature, as well as currents. Surface currents are the water currents that are produced by the atmosphere's currents and its winds blowing over the surface of the water, producing wind waves, setting up through drag slow but stable circulations of water, as in the case of the ocean sustaining deep-sea ocean currents. Deep-sea currents, known together as the global conveyor belt, carry cold water from near the poles to every ocean and significantly influence Earth's climate. Tides, the generally twice-daily rise and fall of sea levels, are caused by Earth's rotation and the gravitational effects of the Moon and, to a lesser extent, of the Sun. Tides may have a very high range in bays or estuaries. Submarine earthquakes arising from tectonic plate movements under the oceans can lead to destructive tsunamis, as can volcanoes, huge landslides, or the impact of large meteorites.

The seas have been an integral element for humans throughout history and culture. Humans harnessing and studying the seas have been recorded since ancient times and evidenced well into prehistory, while its modern scientific study is called oceanography and maritime space is governed by the law of the sea, with admiralty law regulating human interactions at sea. The seas provide substantial supplies of food for humans, mainly fish, but also shellfish, mammals and seaweed, whether caught by fishermen or farmed underwater. Other human uses of the seas include trade, travel, mineral extraction, power generation, warfare, and leisure activities such as swimming, sailing, and scuba diving. Many of these activities create marine pollution.

## Government spending

Government spending or expenditure includes all government consumption, investment, and transfer payments. In national income accounting, the acquisition by governments of goods and services for current use, to directly satisfy the individual or collective needs of the community, is classed as government final consumption expenditure. Government acquisition of goods and services intended to create future benefits, such as infrastructure investment or research spending, is classed as government investment (government gross capital formation). These two types of government spending, on final consumption and on gross capital formation, together constitute one of the major components of gross domestic product.

Spending by a government that issues its own currency is nominally self-financing. However, under a full employment assumption, to acquire resources produced by its population without potential inflationary pressures, removal of purchasing power must occur via government borrowing, taxes, custom duties, the sale or lease of natural resources, and various fees like national park entry fees or licensing fees. When these sovereign governments choose to temporarily remove spent money by issuing securities in its place, they pay interest on the money borrowed. Changes in government spending are a major component of fiscal policy used to stabilize the macroeconomic business cycle.

Public expenditure is spending made by the government of a country on collective or individual needs and wants of public goods and public services, such as pension, healthcare, security, education subsidies, emergency services, infrastructure, etc. Until the 19th century, public expenditure was limited due to laissez faire philosophies. In the 20th century, John Maynard Keynes argued that the role of public expenditure was pivotal in determining levels of income and distribution in the economy. Public expenditure plays an important role in the economy as it establishes fiscal policy and provides public goods and services for households and firms.
