

# 2 Power Law Of Self Thinning

## Non-Newtonian fluid

*thixotropic fluids are extremely shear thinning, but they are significantly time dependent, whereas the colloidal &quot;shear thinning&quot; fluids respond instantaneously*

In physical chemistry and fluid mechanics, a non-Newtonian fluid is a fluid that does not follow Newton's law of viscosity, that is, it has variable viscosity dependent on stress. In particular, the viscosity of non-Newtonian fluids can change when subjected to force. Ketchup, for example, becomes runnier when shaken and is thus a non-Newtonian fluid. Many salt solutions and molten polymers are non-Newtonian fluids, as are many commonly found substances such as custard, toothpaste, starch suspensions, paint, blood, melted butter and shampoo.

Most commonly, the viscosity (the gradual deformation by shear or tensile stresses) of non-Newtonian fluids is dependent on shear rate or shear rate history. Some non-Newtonian fluids with shear-independent viscosity, however, still exhibit normal stress-differences or other non-Newtonian behavior. In a Newtonian fluid, the relation between the shear stress and the shear rate is linear, passing through the origin, the constant of proportionality being the coefficient of viscosity. In a non-Newtonian fluid, the relation between the shear stress and the shear rate is different. The fluid can even exhibit time-dependent viscosity. Therefore, a constant coefficient of viscosity cannot be defined.

Although the concept of viscosity is commonly used in fluid mechanics to characterize the shear properties of a fluid, it can be inadequate to describe non-Newtonian fluids. They are best studied through several other rheological properties that relate stress and strain rate tensors under many different flow conditions—such as oscillatory shear or extensional flow—which are measured using different devices or rheometers. The properties are better studied using tensor-valued constitutive equations, which are common in the field of continuum mechanics.

For non-Newtonian fluid's viscosity, there are pseudoplastic, plastic, and dilatant flows that are time-independent, and there are thixotropic and rheopectic flows that are time-dependent. Three well-known time-dependent non-newtonian fluids which can be identified by the defining authors are the Oldroyd-B model, Walters' Liquid B and Williamson fluids.

Time-dependent self-similar analysis of the Ladyzenskaya-type model with a non-linear velocity dependent stress tensor was performed. No analytical solutions could be derived, but a rigorous mathematical existence theorem was given for the solution.

For time-independent non-Newtonian fluids the known analytic solutions are much broader.

## Moore's law

*months, with no increase in power consumption. Mathematically, Moore's law predicted that transistor count would double every 2 years due to shrinking transistor*

Moore's law is the observation that the number of transistors in an integrated circuit (IC) doubles about every two years. Moore's law is an observation and projection of a historical trend. Rather than a law of physics, it is an empirical relationship. It is an observation of experience-curve effects, a type of observation quantifying efficiency gains from learned experience in production.

The observation is named after Gordon Moore, the co-founder of Fairchild Semiconductor and Intel and former CEO of the latter, who in 1965 noted that the number of components per integrated circuit had been

doubling every year, and projected this rate of growth would continue for at least another decade. In 1975, looking forward to the next decade, he revised the forecast to doubling every two years, a compound annual growth rate (CAGR) of 41%. Moore's empirical evidence did not directly imply that the historical trend would continue; nevertheless, his prediction has held since 1975 and has since become known as a law.

Moore's prediction has been used in the semiconductor industry to guide long-term planning and to set targets for research and development (R&D). Advancements in digital electronics, such as the reduction in quality-adjusted prices of microprocessors, the increase in memory capacity (RAM and flash), the improvement of sensors, and even the number and size of pixels in digital cameras, are strongly linked to Moore's law. These ongoing changes in digital electronics have been a driving force of technological and social change, productivity, and economic growth.

Industry experts have not reached a consensus on exactly when Moore's law will cease to apply. Microprocessor architects report that semiconductor advancement has slowed industry-wide since around 2010, slightly below the pace predicted by Moore's law. In September 2022, Nvidia CEO Jensen Huang considered Moore's law dead, while Intel's then CEO Pat Gelsinger had that of the opposite view.

## Inductance

Inductance is the tendency of an electrical conductor to oppose a change in the electric current flowing through it. The electric current produces a magnetic field around the conductor. The magnetic field strength depends on the magnitude of the electric current, and therefore follows any changes in the magnitude of the current. From Faraday's law of induction, any change in magnetic field through a circuit induces an electromotive force (EMF) (voltage) in the conductors, a process known as electromagnetic induction. This induced voltage created by the changing current has the effect of opposing the change in current. This is stated by Lenz's law, and the voltage is called back EMF.

Inductance is defined as the ratio of the induced voltage to the rate of change of current causing it. It is a proportionality constant that depends on the geometry of circuit conductors (e.g., cross-section area and length) and the magnetic permeability of the conductor and nearby materials. An electronic component designed to add inductance to a circuit is called an inductor. It typically consists of a coil or helix of wire.

The term inductance was coined by Oliver Heaviside in May 1884, as a convenient way to refer to "coefficient of self-induction". It is customary to use the symbol

L

for inductance, in honour of the physicist Heinrich Lenz. In the SI system, the unit of inductance is the henry (H), which is the amount of inductance that causes a voltage of one volt, when the current is changing at a rate of one ampere per second. The unit is named for Joseph Henry, who discovered inductance independently of Faraday.

## Fusion power

Fusion power is a proposed form of power generation that would generate electricity by using heat from nuclear fusion reactions. In a fusion process, two lighter atomic nuclei combine to form a heavier nucleus,

while releasing energy. Devices designed to harness this energy are known as fusion reactors. Research into fusion reactors began in the 1940s, but as of 2025, only the National Ignition Facility has successfully demonstrated reactions that release more energy than is required to initiate them.

Fusion processes require fuel, in a state of plasma, and a confined environment with sufficient temperature, pressure, and confinement time. The combination of these parameters that results in a power-producing system is known as the Lawson criterion. In stellar cores the most common fuel is the lightest isotope of hydrogen (protium), and gravity provides the conditions needed for fusion energy production. Proposed fusion reactors would use the heavy hydrogen isotopes of deuterium and tritium for DT fusion, for which the Lawson criterion is the easiest to achieve. This produces a helium nucleus and an energetic neutron. Most designs aim to heat their fuel to around 100 million Kelvin. The necessary combination of pressure and confinement time has proven very difficult to produce. Reactors must achieve levels of breakeven well beyond net plasma power and net electricity production to be economically viable. Fusion fuel is 10 million times more energy dense than coal, but tritium is extremely rare on Earth, having a half-life of only ~12.3 years. Consequently, during the operation of envisioned fusion reactors, lithium breeding blankets are to be subjected to neutron fluxes to generate tritium to complete the fuel cycle.

As a source of power, nuclear fusion has a number of potential advantages compared to fission. These include little high-level waste, and increased safety. One issue that affects common reactions is managing resulting neutron radiation, which over time degrades the reaction chamber, especially the first wall.

Fusion research is dominated by magnetic confinement (MCF) and inertial confinement (ICF) approaches. MCF systems have been researched since the 1940s, initially focusing on the z-pinch, stellarator, and magnetic mirror. The tokamak has dominated MCF designs since Soviet experiments were verified in the late 1960s. ICF was developed from the 1970s, focusing on laser driving of fusion implosions. Both designs are under research at very large scales, most notably the ITER tokamak in France and the National Ignition Facility (NIF) laser in the United States. Researchers and private companies are also studying other designs that may offer less expensive approaches. Among these alternatives, there is increasing interest in magnetized target fusion, and new variations of the stellarator.

## Solar power

Solar power, also known as solar electricity, is the conversion of energy from sunlight into electricity, either directly using photovoltaics (PV) or indirectly using concentrated solar power. Solar panels use the photovoltaic effect to convert light into an electric current. Concentrated solar power systems use lenses or mirrors and solar tracking systems to focus a large area of sunlight to a hot spot, often to drive a steam turbine.

Photovoltaics (PV) were initially solely used as a source of electricity for small and medium-sized applications, from the calculator powered by a single solar cell to remote homes powered by an off-grid rooftop PV system. Commercial concentrated solar power plants were first developed in the 1980s. Since then, as the cost of solar panels has fallen, grid-connected solar PV systems' capacity and production has doubled about every three years. Three-quarters of new generation capacity is solar, with both millions of rooftop installations and gigawatt-scale photovoltaic power stations continuing to be built.

In 2024, solar power generated 6.9% (2,132 TWh) of global electricity and over 1% of primary energy, adding twice as much new electricity as coal.

Along with onshore wind power, utility-scale solar is the source with the cheapest levelised cost of electricity for new installations in most countries.

As of 2023, 33 countries generated more than a tenth of their electricity from solar, with China making up more than half of solar growth.

Almost half the solar power installed in 2022 was mounted on rooftops.

Much more low-carbon power is needed for electrification and to limit climate change. The International Energy Agency said in 2022 that more effort was needed for grid integration and the mitigation of policy, regulation and financing challenges. Nevertheless solar may greatly cut the cost of energy.

## Law of the European Union

It has grown over time since the 1952 founding of the European Coal and Steel Community, to promote peace, social justice, a social market economy with full employment, and environmental protection. The Treaties of the European Union agreed to by member states form its constitutional structure. EU law is interpreted by, and EU case law is created by, the judicial branch, known collectively as the Court of Justice of the European Union.

Legal Acts of the EU are created by a variety of EU legislative procedures involving the popularly elected European Parliament, the Council of the European Union (which represents member governments), the European Commission (a cabinet which is elected jointly by the Council and Parliament) and sometimes the European Council (composed of heads of state). Only the Commission has the right to propose legislation.

Legal acts include regulations, which are automatically enforceable in all member states; directives, which typically become effective by transposition into national law; decisions on specific economic matters such as mergers or prices which are binding on the parties concerned, and non-binding recommendations and opinions. Treaties, regulations, and decisions have direct effect – they become binding without further action, and can be relied upon in lawsuits. EU laws, especially Directives, also have an indirect effect, constraining judicial interpretation of national laws. Failure of a national government to faithfully transpose a directive can result in courts enforcing the directive anyway (depending on the circumstances), or punitive action by the Commission. Implementing and delegated acts allow the Commission to take certain actions within the framework set out by legislation (and oversight by committees of national representatives, the Council, and the Parliament), the equivalent of executive actions and agency rulemaking in other jurisdictions.

New members may join if they agree to follow the rules of the union, and existing states may leave according to their "own constitutional requirements". The withdrawal of the United Kingdom resulted in a body of retained EU law copied into UK law.

## Michel Foucault

Paul-Michel Foucault (UK: FOO-koh, US: foo-KOH; French: [pʁ̥ miˈʁ̥ fuko]; 15 October 1926 – 25 June 1984) was a French historian of ideas and philosopher, who was also an author, literary critic, political activist, and teacher. Foucault's theories primarily addressed the relationships between power versus knowledge and liberty, and he analyzed how they are used as a form of social control through multiple institutions. Though often cited as a structuralist and postmodernist, Foucault rejected these labels and sought to critique authority without limits on himself. His thought has influenced academics within a large number of contrasting areas of study, with this especially including those working in anthropology, communication studies, criminology, cultural studies, feminism, literary theory, psychology, and sociology. His efforts

against homophobia and racial prejudice as well as against other ideological doctrines have also shaped research into critical theory and Marxism–Leninism alongside other topics.

Born in Poitiers, France, into an upper-middle-class family, Foucault was educated at the Lycée Henri-IV, at the École Normale Supérieure, where he developed an interest in philosophy and came under the influence of his tutors Jean Hyppolite and Louis Althusser, and at the University of Paris (Sorbonne), where he earned degrees in philosophy and psychology. After several years as a cultural diplomat abroad, he returned to France and published his first major book, *The History of Madness* (1961). After obtaining work between 1960 and 1966 at the University of Clermont-Ferrand, he produced *The Birth of the Clinic* (1963) and *The Order of Things* (1966), publications that displayed his increasing involvement with structuralism, from which he later distanced himself. These first three histories exemplified a historiographical technique Foucault was developing, which he called "archaeology".

From 1966 to 1968, Foucault lectured at the University of Tunis, before returning to France, where he became head of the philosophy department at the new experimental university of Paris VIII. Foucault subsequently published *The Archaeology of Knowledge* (1969). In 1970, Foucault was admitted to the Collège de France, a membership he retained until his death. He also became active in several left-wing groups involved in campaigns against racism and other violations of human rights, focusing on struggles such as penal reform. Foucault later published *Discipline and Punish* (1975) and *The History of Sexuality* (1976), in which he developed archaeological and genealogical methods that emphasized the role that power plays in society.

Foucault died in Paris from complications of HIV/AIDS. He became the first public figure in France to die from complications of the disease, with his charisma and career influence changing mass awareness of the pandemic. This occurrence influenced HIV/AIDS activism; his partner, Daniel Defert, founded the AIDES charity in his memory. It continues to campaign as of 2024, despite the deaths of both Defert (in 2023) and Foucault (in 1984).

## Rule of law

*equality of all citizens before the law, secures a nonarbitrary form of government, and more generally prevents the arbitrary use of power.&quot; Legal scholars*

The essence of the rule of law is that all people and institutions within a political body are subject to the same laws. This concept is sometimes stated simply as "no one is above the law" or "all are equal before the law". According to Encyclopædia Britannica, it is defined as "the mechanism, process, institution, practice, or norm that supports the equality of all citizens before the law, secures a nonarbitrary form of government, and more generally prevents the arbitrary use of power."

Legal scholars have expanded the basic rule of law concept to encompass, first and foremost, a requirement that laws apply equally to everyone. "Formalists" add that the laws must be stable, accessible and clear. More recently, "substantivists" expand the concept to include rights, such as human rights, and compliance with international law.

Use of the phrase can be traced to 16th-century Britain. In the following century, Scottish theologian Samuel Rutherford employed it in arguing against the divine right of kings. John Locke wrote that freedom in society means being subject only to laws written by a legislature that apply to everyone, with a person being otherwise free from both governmental and private restrictions of liberty. The phrase "rule of law" was further popularized in the 19th century by British jurist A. V. Dicey. However, the principle, if not the phrase itself, was recognized by ancient thinkers. Aristotle wrote: "It is more proper that law should govern than any one of the citizens."

The term rule of law is closely related to constitutionalism as well as Rechtsstaat. It refers to a political situation, not to any specific legal rule. Distinct is the rule of man, where one person or group of persons rule

arbitrarily.

## Thin-slicing

Thin-slicing is a term used in psychology and philosophy to describe the ability to find patterns in events based only on "thin slices", or narrow windows, of experience. The term refers to the process of making very quick inferences about the state, characteristics or details of an individual or situation with minimal amounts of information. Research has found that brief judgments based on thin-slicing are similar to those judgments based on much more information. Judgments based on thin-slicing can be as accurate, or even more so, than judgments based on much more information.

The first recorded use of the term was in 1992 by Nalini Ambady and Robert Rosenthal in a meta-analysis in the Psychological Bulletin. Since then, thin-slicing has been applied to many domains, and has been used to make various types of judgments. A non-exhaustive list of domains includes interpersonal relationship, clinical studies, education, etc.

## Disk laser

A disk laser or active mirror (Fig.1) is a type of diode pumped solid-state laser characterized by a heat sink and laser output that are realized on opposite sides of a thin layer of active gain medium. Despite their name, disk lasers do not have to be circular; other shapes have also been tried. The thickness of the disk is considerably smaller than the laser beam diameter. Initially, this laser cavity configuration had been proposed and realized experimentally for thin slice semiconductor lasers.

The disk laser concepts allow very high average and peak powers due to its large area, leading to moderate power densities on the active material.
