Holding company

A holding company is a company whose primary business is holding a controlling interest in the securities of other companies. A holding company usually

A holding company is a company whose primary business is holding a controlling interest in the securities of other companies. A holding company usually does not produce goods or services itself. Its purpose is to own stock of other companies to create a corporate group.

Holding companies also conduct trade and other business activities themselves. Holding companies reduce risk for the shareholders, and can permit the ownership and control of a number of different companies. They can be subsidiaries in a tiered structure.

Holding companies are also created to hold assets such as intellectual property or trade secrets that are protected from the operating company. That creates a smaller risk when it comes to litigation.

In the United States, 80% of stock, in voting and value, must be owned before tax consolidation benefits such as tax-free dividends can be claimed. That is, if Company A owns 80% or more of the stock of Company B, Company A will not pay taxes on dividends paid by Company B to its stockholders, as the payment of dividends from B to A is essentially transferring cash within a single enterprise. Any other shareholders of Company B will pay the usual taxes on dividends, as they are legitimate and ordinary dividends to these shareholders.

In some jurisdictions around the world, holding companies are called parent companies. The New York Times uses the term parent holding company. Sometimes, a company intended to be a pure holding company identifies itself as such by adding "Holding" or "Holdings" to its name.

ASML Holding

ASML Holding N.V. (commonly shortened to ASML, originally standing for Advanced Semiconductor Materials Lithography) is a Dutch multinational corporation

ASML Holding N.V. (commonly shortened to ASML, originally standing for Advanced Semiconductor Materials Lithography) is a Dutch multinational corporation that specializes in the development and manufacturing of photolithography machines which are used to produce integrated circuits. As of 2023 it is the largest supplier for the semiconductor industry and the sole supplier in the world of extreme ultraviolet lithography (EUVL) photolithography machines that are required to manufacture the most advanced chips. As of November 2024, ASML was the fourth most valuable company in Europe, and the second most valued European tech company, with a market capitalization of about US\$264 billion.

ASML was founded in 1984 as a joint venture between the Dutch technology companies Philips and ASM International. It became a fully independent corporation in 1995. ASML's corporate headquarters is in Veldhoven, Netherlands and is the location for research, development, manufacturing and assembly. ASML employs more than 42,000 people from 143 nationalities and relies on a network of nearly 5,000 tier 1 suppliers. ASML has a worldwide customer base and over 60 service points in 16 countries. It has offices in the Netherlands, the United States, Belgium, France, Germany, Ireland, Israel, Italy, the United Kingdom, China, Hong Kong, Japan, South Korea, Malaysia, Singapore, and Taiwan.

The company is listed on both the AEX and Nasdaq stock exchanges, as ASML. It is also a component of the Euro Stoxx 50 and Nasdaq-100.

Michael Anthony Holding (born 16 February 1954) is a Jamaican former cricketer and commentator who played for the West Indies cricket team. Widely regarded as one of the greatest pace bowlers in cricket history, he was nicknamed "Whispering Death" due to his undramatic but effective bowling style.

Holding was a key member of the West Indies team that won the 1979 Cricket World Cup, as well as finishing as runners-up at the 1983 Cricket World Cup. He had the most wickets for his team at the 1979 tournament. His bowling action was renowned for being smooth and extremely fast, and he used his height (192 cm (6 ft 4 in)) to generate large amounts of bounce and zip off the pitch. He was part of the fearsome West Indian pace bowling battery, together with Andy Roberts, Joel Garner, Colin Croft, Wayne Daniel,

Malcolm Marshall and Sylvester Clarke, that devastated opposing batting line-ups throughout the world in the late seventies and early eighties. Early in his Test career, in 1976, Holding broke the record for best bowling figures in a Test match by a West Indies bowler, 14 wickets for 149 runs (14/149). The record still stands.

During his first-class cricket career, Holding played for Jamaica, Canterbury, Derbyshire, Lancashire, and Tasmania. In September 2021, Holding announced his retirement from being a commentator.

Holding space

The concept of "holding" was coined by Donald Winnicott in 1960 in a paper on the relationship of infants and parents and has since seen evolving use in the field of psychotherapy. The term "holding space" was popularized around 2015 by Heather Plett in a blog post about the concept.

In popular culture, the phrase "holding space" gained a rapid rise in popularity following an interview in November 2024 between journalist Tracy E. Gilchrist and Wicked actresses Cynthia Erivo and Ariana Grande.
